Kidnapping Suspects arrested**

February 17, 2016

An investigation into a kidnapping early Tuesday morning has led to several arrests last night. A 20-year-old female reported that she had been taken against her will, bound, and placed in a car trunk for several hours. This took place late Monday night or very early Tuesday morning. She was eventually released in Umatilla County, Oregon, on Weston Mountain Road. She reported the incident at about 6:00 a.m. after walking to a nearby home and was transported to WWPD by a Umatilla County Sheriff's Office Deputy.

The investigation continued throughout the day and evening hours by Detectives and the Career Criminal Apprehension Team (CCAT). Four arrests have been made thus far for crimes to include 1<sup>st</sup> Degree Robbery, 1<sup>st</sup> Degree Rape, 1<sup>st</sup> Degree Kidnapping, Possession of Methamphetamine, Assault 4<sup>th</sup> Degree, and 3<sup>rd</sup> Degree Theft.

At about 5:00 p.m., Detectives from the CCAT attempted to stop a gray minivan driven by Bailee K. Foster, 18. A pursuit was initiated in the area of Melrose and Clinton Streets when the van failed to stop for the officers. The pursuit ended a short time later when Foster lost control of the vehicle and struck an SUV and a retaining wall in the 1000 block of Bonsella. Other occupants of the vehicle were identified as Ismael A. Rojas-Barcott, 24, and D'Sean EM Marks, 23.

Foster and Marks were taken into custody for 1<sup>st</sup> Degree Robbery, 1<sup>st</sup> Degree Rape, 1<sup>st</sup> Degree Kidnapping, Possession of Methamphetamine, Assault 4<sup>th</sup> Degree, and 3<sup>rd</sup> Degree Theft. Foster was also lodged for Felony Eluding and Possession of Methamphetamine.

Rojas was lodged on felony warrants from Oregon and Walla Walla for prior incidents as well as Possession of Methamphetamine.

Detectives had information that one of the suspects, Shawn A. Crump, 24, frequented a residence in the 200 block of Orchard Street. The house was kept under surveillance until it could be confirmed that he was inside. He was taken into custody shortly after 9:00 p.m. for the above listed charges and found to have a "large chunk" of suspected Methamphetamine on his person.
